This indenture, made and entered into this 28th day of October, 1918, between Charles Page of Pulsa, Oklahoma, of the first part, and hereinafter designated the seller, and Mrs. Bertha Harman, of Sand Springs, Oklahoma, of the second part, hereinafter designated the purchaser.

Witnesseth: That whereas, Charles Dage, is the founder of the Sand Springs Home, located in the County of Tulsa, State of Oklahoma, and in the vicinity of the lands hereinafter described, and proposes to incorprate the same as a charitable organization under the laws of the State of Oklahoma, and

Now, for and in consideration of the sum of three hundred seventy five, (\$375.00) dollars, in hand paid, the receipt of which is hereby acknowledged, and also for the further consideration of the agreement between the parties hereto, for themselves, their heirs, successors and legal repreentatives, that intoxicating liquors shall never be manufactured, sold or otherwise disposed of, as a beverage, in any place of public resort, in and upon the premises hereby granted, or any part thereof, and the express reservation to the Seller, his heirs and assigns, that in case that any of the conditions concerning intoxicating liquors are broken by the purchaser, his heirs, successors, assigns, or legal representatives, then this deed shall become null and void and all right, title and interest in and to the premises hereby conveyed, shall revert to the said Sand Springs Home, a corporation, to be formed as aforesaid, its succesors and assigns, and the purchaser, by accepting this deed for himself, his heirs, executors, administrators, successors and assigns, consents and agrees to this reservation and condition, as well's to the reservations, conditions, and agreements hereinafter set out, the said seller further, excepting and reserving unto himself, hie heirs and assigns, the oil gas, fire clay, coal and all other minerals lying in and under the premises hereinafter described, does hereby bargain, sell, convey and confirm, unto the purchaser, his heirs, successors and assigns, forever, the following described premises, situated in the town of Sand Springs, County of Pulsa, State of Oklahoma, to-wit: Lots number one (1) and two (2) in Block number forty two (42) of the original townsite to Sand Springs, Oklahoma. The purchaser to pay all taxes, and assessments imposed by public authority which becomes a lien on said premises after the expiration of the year 1915, according to the recorded plat of Sand Springs, made to W. H. Hendren, Civil Engineer, and certified under date of 17th of June, 1911, and recorded in the office of Register Deeds, Tulsa County, Oklahoma, in the 19th day of July, 1911.

To have and to hold the same, together with all and singular the temements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, and warrant the title tomthe same, anto the said purchaser, his heirs, successors and assigns, forever, subject nevertheless, to the conditions and reservations and agreements hereinbefore and hereinafter set forth, according to the true intent and meaning thereof.

And the seller, for himself and his heirs and assigns, does hereby covenant, promise and agree to and with the purchaser, his hers, executors, administrators, successors and assigns, that the said premises are free, clear and discharged of and from all former grants, charges, except for improvement as hereinafter stated, judgements, mortgages and other liens and encumbrances of whatsoever nature and kind.
