## APPROVAL OF GUARDIAN'S DEED.

The above entitled matter coming on to be heard upon the 21st, day of December, 1922, upon the petition of H. A. Guess, attorney for Tuxie Roach, guardian of Crawford Roach, a minor, for the approval of a certain conveyance of the property of the said minor to the City of Tulsa, Oklahoma, a municipal corporation, and the court being fully advised in the premises, finds:

- (1) That the said Tuxie Roach is the duly appointed, acting and legally qualified guardian of the estate of Crawford Roach, a minor, who is a resident of Tulsa County, Ok ahoma.
- (2) That the said Crawford Roach is the owner of the following described land located in Tulsa County, Oklahoma, to-wit:

An undivided one-fifth interest (1/5) in and to the Northeast quarter (NE 1/4) of the Southeast quarter (SE 1/4) of the Northeast quarter (NE 1/4) of Section Sixteen (16), Township Twenty (20) North, Range Thirteen (13) East, containing two(2) acres more of less.

- (3) That the City of Tulsa, Oklahoma, is a municipal corporation duly organized and existing under and by virtue of the laws of the State of Oklahoma, operating and being governed under the provisions of a Charter duly and legally adopted by the qualified electors thereof.
- (4) That under the provisions of the said Charter, and under the laws of the State of Oklahoma, is entitled and authorized to acquire, by condemnation or private purchase, in the manner provided by statute, lands of a minor, whenever the same may be necessary to be used for public purpose.
- (5) The Court further finds that for the purpose of acquiring an adequate water supply system for the City of Tulsa, Oklahoma, it has been deemed necessary for the City to construct a pipe line or conduit across or over said certain potions of the lands of said minor, and that it has been declared necessary by the said city to acquire a right of way across said lands belonging to said minor.
