And it being further shown to the Court that J. S. Severson, attorney for plaintiff, has performed valuable services in this cause and he is entitled to a fee of Six Hundred Dollars; and it further appearing that Jas. S. Watson has performed valuable services as attorney for defendants in this case and that he is entitled to a fee of Six Hundred Dollars and the further sum of Forty-Five Dollars (\$45.00) for abstract and certified cop; of proceedings, and that said attorney fees for plaintiff and defendants and the cost of said abstrace and certified copies shoulb be taxed as cost in this case.

It is therefore ordered, adjudged and decreed by the Court that said Sheriffs sale of the premises herein be, and the same is, in all things confirmed and approved and that Dan W. Patton and F. M. Wooden, thepruchaser, be subrogated to all the rights of all af the parties fro the protection of their said title.
