LILLIE G. TRULLINGER, being first duly sworn, on he oath, says:

That she is now and for more than 10 years last past has been a resident of Tulsa County, Oklahoma;

That she is the widow of William F.Trullinger, who died intestate, at Tulsa County, Oklahoma, on or about the 12th, day of March, 19th;

That at the date of the death of said William F.Trullinger and for a period of about three years immediately proir thereto, said William F. Trullinger and affiant, together with their childred hereinafter named actually resided upon, used and occupied as their family homestead under the laws of Oklahoma, the following described tract of land, to-wit:

The North one-half of the Northwest Quarter of Section Sixteen (16), in Township Nineteen (19) North, Range Fourteen (14) East, containing eighty (80) acres, more or less, in Tulsa County, Oklahoma;

said land having been pruchased by affiant and her said husband from C. C. C. White and wife, by deed dated December 23, 1910, and recorded in Book 88, at page 25, of the records of the County Clerk's office for said County.

That affiant personally paid all of the debts, funeral expenses and expenses of last illness of the said William F. Trullinger,

Affiant further states that at the date of the death of said William F.Trullinger, he left him surviving as his sole heirs at law, the following persons, to-wit:

Lillie G. Trullinger, his widow, being affiant;

- 1. Dale Messimore, nee Trullinger, wife of Charles Messimore;
- 2. Grace V.Trullinger, who afterwards intermarried with one R. E./Smittle;
- 3. One Trullinger, who afterwards intermarried with one Robert D. Smittle;
- 4. Ruth Trullinger and
- 5. Billie or William Trullinger; said Grace V. Dale, One, Ruth and Billie" or William above named being the children of affiant and said William F. Trullinger.

That said William F. Trullinger left no other shild or childred, nor any descendants of any deceased child or childred.

Affiant further states that the "Billie" Trullinger mentioned in petition for Letters of Guardianship, the Order appointing affiant as Guardian and the Letters of Tuardianship issued to affiant by the Count, Court for Tulsa County, Oklahama, in Probate Case No 2356, in one and the same person as the William Trullinger named in the petition, order, notices, decree and confirmation of sale of the interest of said manor in the real estate hereinbefore described, being the son of affiant and said William F. Trullinger as above stated.

Affiant further states that the Grace V.Smittle and Ona Smittle, named as two of the grantors in that certain quit claim deed dated September 29th, 1921, to affiant as grantee, for the lands above described are the same persons as the Grace Trullinger, and Ona Trullinger, respectively, named in the petition for appointment of guardian as above referred to.

Affiant further states that the tract of land above described is now owned by Charles F. Kaiser, of Tulsa, Oklahoma, and that his title and possession thereof has never been and is not now questioned or disputed.
