(a) This trust shall continue from the date hereof for a period of twenty years, at which time the then trustee shall proceed to wind up its affairs, liquidate its assets, and distribute the same among the cestui que trust as according to the values, priorities and conditions of the certificates, if any, held by them, be therein expressed.

(b) For the purpose of winding up the affairs and liquidating the assets of the trust, the then trustee shall continue in office until such duties have been fully performed.
