DECLARATION OF TRUST

COMPARED

WHEREAS, Louana Smith has caused a deed to be made dated June 19th, 1919, to Allen Jones, conveying to him such legal and equitable title as she may have in and to all of certain lands situated in the County of Wagoner and State of Oklahoma, more fully described as follows: The West Half of the Southwest quarter of the Southeast Quarter of the Southwest quarter of Section 35, Township 19, North, in Range 14 East; and

Whereas, the purpose of said conveyance to said Allen Jones is to merge the title to said lands in him; and

Whereas, by the common consent of Allen Jones and Louana Smith, each are owners of an undivided half and are beneficiaries to this trust, the said undersigned, Allen Jones has been selected as trustee by Louana Smith and Allen Jones to carry out the purposes herein set forth, and therefore, this is to declare that the undersigned, Allen Jones acknowledged himself to be the trustee for Louana Smith to the extent of fifty (50) per cent of the proceeds of said real estate, and Allen Jones to the amount of Fifty (50) percent of the proceeds of said real estate, and promises to deliver to said Louana Smith a respective amount of the proceeds equal to the statement ^{from time} to time as said land may be sold and conveyed by the said trustee. And in case that no sale is had, or disposition made of the same, the said land shall be conveyed by this trustee to the said parties; that is, to Louana Smith and Allen Jones, in accordance with their proportionate share as shown by this instrument, as soon as title is perfected to said land by decree of the court or otherwise.
