DECREE OF DISTRIBUTION

This cause coming on to be heard this 27th, day of April, 1923, upon petition of Margaret E. Reynolds, sole devisee and legatee under the terms and provisions of the Last will and Testament of W. A. Reynolds, deceased, praying that a partial distribution of said estate of said W. A. Reynolds, deceased, be made at this time, and the Court, upon hearing of said petition in open Court, being fully advised in the premises finds:

That Letters of Administration with the Will annexed on the estate of W.A. Reynolds, a deceased, were, by this Court, granted to EXCHANGE TRUST COMPANY a corporation, of Tulsa, Oklahoma, on the 16th, day of October 1922, and more than four months prior to the date of filing said petition for partial distribution.

That notice to creditors to present claims against said estate has been given and posted and published as required by law, and that the time within which creditors may file claims against said estate has expired, and that this Court has made and entered its decree barring creditors.

That all claims presented to said EXCHANGE TRUST COMPANY, as Administrator with the Will annexed of said estate have been duly allowed, approved and paid, and that no debts of said estate remain unpaid.
