Now if the said first parties shall pay or cause to be paid to said second party its heirs or assigns said sums of money in the above described nots mentioned, together with the interest thereon according to the terms and tenor of said notes and shall make and maintain such insurance and pay such taxes and assessments then these presents shall be wholly discharged and void, otherwise shall remain in full force and effect.
