

THIS INDENTURE, Made this 15th day of June, 1923, between
Sophia E. Walker, a widow

in Tulsa County, and State of Oklahoma, part of the first part, and the
HOME SAVINGS AND LOAN ASSOCIATION, a corporation organized under the laws of the State of Oklahoma, party of the second part.

WITNESSETH, That the said part of the first part, for and in consideration of the sum of

in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has sold and by these presents GRANT,
BARGAIN, SELL, CONVEY and CONFIRM unto said party of the second part, its successors and assigns forever, all the following described real estate,
lying and situated in the County of Tulsa and State of Oklahoma, to-wit:

Lot Two (2), Block Three (3), Hackathorn Addition
to the City of Tulsa, Oklahoma, according to the
recorded plat thereof, together with all improvements
thereon.

And all right, title, estate and interest of said grantor in and to said premises, including all homestead rights, which are hereby waived and released, to-
gether with all rents of said property, with full power and authority to collect the same in case the conditions of this mortgage become broken in any par-
ticular, and with all and singular the tenements, hereditaments and appurtenances thereto belonging. A first and specific lien is hereby granted on all rentals
and profits accruing from said property from and after this date.

TO HAVE AND TO HOLD THE SAME unto said party of the second part, its successors and assigns forever. Said part of the first part hereby
covenant with said party of the second part, its successors and assigns, that at the delivery hereof

she is
the true and lawful owner of the said premises above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all in-
cumbances; that there is no one in adverse possession of same and that

she
will warrant and defend the same against the lawful and equitable claims of all persons whomsoever.

PROVIDED, ALWAYS, And these presents are upon the express conditions that, whereas, the said party of the second part at the special instance and
request of the part of the first part, loaned and advanced to

Sophia E. Walker, a widow the sum
of Five Hundred and No/100 DOLLARS,

AND WHEREAS, said part of the first part agree with the said party of the second part, its successors and assigns, to pay all taxes and assess-
ments, general and special, against said lands and improvements thereon, when due, and to keep said improvements in good repair, and to keep the build-
ings thereon constantly insured in such company or companies as said second party may designate and the policy or policies of insurance constantly trans-
ferred to said party of the second part, its successors or assigns; and also to keep said lands and improvements thereon free from all statutory lien claims of
every kind, and if any or either of said agreements be not performed as aforesaid then said party of the second part its successors or assigns, may pay such
taxes and assessments, and may effect such insurance, for such purpose, paying the costs thereof, and may also pay the final judgment for any statutory lien
claims, and may invest such sums as may be necessary to protect the title or possession of said premises, including all costs and for the repayment of all moneys
so expended together with the charges thereon as provided by the By-Laws of said Association, these presents shall be security.

AND WHEREAS, the said Sophia E. Walker, a widow
did on the 15th day of June, 1923 make and deliver to the
HOME SAVINGS AND LOAN ASSOCIATION her
their note or obligation, which is made a part hereof and in the words and figures as follows, to-wit:

Bartlesville Tulsa, Oklahoma, June 15th, 1923

For Value Received, I promise to pay to the order of HOME SAVINGS AND LOAN ASSOCIATION, the following sums of money viz:
The sum of Seven and No/100 DOLLARS,
the same being the monthly dues on the 5 share of the capital stock of said Association, represented and evidenced by the
Certificate therefor numbered A-380 this day pledged by

Sophia E. Walker to said Association to secure a loan of
Five Hundred and No/100 DOLLARS, and the sum of
Four and No/100 DOLLARS; the same being the interest
due monthly upon said sum so borrowed by me and I promise to pay said Association at its Home Office at Bartlesville,
the said sums of money, amounting in the aggregate to Eleven and No/100 Oklahoma DOLLARS;
on the 15th day of each and every month, and continue such monthly payments for a term of 60 months from the date hereof.
