SPECIAL SEWER CONTRACT.

This agreement, made and entered into this the 26th day of January, 1924, by and between the City of Tulsa, Oklahoma, party of the first part, and H. H. Marshall, of Tulsa, County, Okla., State, part of the second part, Witnesseth:

For and in consideration of the use of and connection with the sewer system in sewer District No. 175, of said City of Tulsa, and the covenants and agreements herein contained, the said part of the second part do hereby covenant and agree with the said City of Tulsa, Oklahoma, as follows, to-wit:

That the said part of the second part, the fee owner of the following property covered by this contract, to-wit:

Lot 11, Block 4, Crutchfield addition to the City of
Tulsa, Okla.,

That the said part of the second part hereby authorized and permitted to construct, connect with and make use of the sewer in Sewer District No. 175, of the City of Tulsa, upon the said part of the second part paying the entire cost of such sewer construction, connection and use, and in addition ^{paying} to the said City of Tulsa, the sum of five (5%) per centum the cost of such construction, connections and use, as an engineering fee for the supervi-
