(8) an undivided one-third interest in and to the north half ($N\frac{1}{2}$) of southwest quarter ($SW\frac{1}{4}$) and the southeast quarter ($SE\frac{1}{4}$) of southwest quarter ($SW\frac{1}{4}$) (less three acres in the southeast corner thereof) of section twenty four (24) township eighteen (18) north, range thirteen (13) east, Tulsa County, Oklahoma, which said tract was purchased with funds borrowed in the name of the Wooden Realty Company, as hereinafter set out.
