If the estato of either party hereto is assigned, and the privilege of assigning in whole or in part is expressly allowed, - the covenants hereof shall extend to their heirs, executors, administrators, successors or assigns, but no change in the ownership of the land or asignment of rentals or royalties shall be binding on the lessee until after the lessee has been furnished with a written transfer or assignment or a true copy thereof; and it is hereby agreed that in this event this lease shall be assigned as to a part or as to parts of the above described lands and the assignee or assigns of such part or parts shall fail or make default in the payment of the proportimate part of the rents due from him or them, such default shall mot operate to defeator affect this lease inso far as it covers a part or parts of said lands upon which the said lessee or any assignee thereof shall make due payment of said restal.

Lessor hereby warrants and agrees to defend the title to the lands herein described, and agrees that the lesse shall have the rights at any time to redeem for lessor, by payment, any mortgages, taxes or other lienson the above described lands, in the event of default of payment by lessor, and be subrogated to the right of the holder thereof, if operatims for a test well are not commenced on this property within sixty days from date of delivery of this lease and continued with due diligence, this lease shall be null and void, to all parties thereto. Any and all royalties which may accrue under this lease are to be divided between the lessors signatory to the amount of acreage owned by each.
