the city of Tulsa, its officers, agents employees and contractors, the right to enter upon said premises and strip of land for the purpose of laying, operating, repairing, re-laying and maintaining said sewer line; and for the further purpose of enabling the said city of Tulsa to do any and all necessary and convenient things incident to the construction, operation, maintenance and repair of such sewer line.

In consideration of the stipulations, covenants and agreements hereinabove set forth and as a further consideration for the construction, operation and maintanance of said sewerline by the City of Tulsa, Cklahoma, the undersigned, by these presents, hereby absolves and releases the said City of Tulsa, from any and all claims for damages, either in law or in equity, that the undersigned might have or claims against said City by reason or on account of the construction, operation or maintenance of said sewer line.

To have and to hold such easement and right of way unto the City of Tulsa, its successors or assigns, forever.
