

the city of Tulsa, its officers, agents employees and contractors, the right to enter upon said premises and strip of land for the purpose of laying, operating, repairing, re-laying and maintaining said sewer line; and for the further purpose of enabling the said city of Tulsa to do any and all necessary and convenient things incident to the construction, operation, maintenance and repair of such sewer line.

In consideration of the stipulations, covenants and agreements hereinabove set forth and as a further consideration for the construction, operation and maintenance of said sewerline by the City of Tulsa, Oklahoma, the undersigned, by these presents, hereby absolves and releases the said City of Tulsa, from any and all claims for damages, either in law or in equity, that the undersigned might have or claims against said City by reason or on account of the construction, operation or maintenance of said sewer line.

To have and to hold such easement and right of way unto the City of Tulsa, its successors or assigns, forever.

CITY OF TULSA
SEWER EASEMENT.

Know all men by these presents: That the undersigned, the owner of the legal and equitable title in and to lot 33, block Bungalow Court addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof; do by these presents, in consideration of the construction, operation and maintenance of a sewerline in the vicinity of the above described property, and which will serve the same, grant, and convey unto the City of Tulsa, Oklahoma, an easement in and to that part or portion of the lot and block above described, owned by the undersigned or as much thereof as may be necessary for sewer purposes, described as follows, to-wit:

A strip of ground not to exceed ten (10) feet wide on either side of the center line of said sewer, as shown by the blue prints on file in the Engineer's office and the storm sewer constructed in accordance therewith, the center line of said twenty (20) foot strip being more particularly described as follows, to-wit:

Ten (10) feet on either side of a line described as follows:

beginning on the east line of lot thirty three (33) Bungalow Court
