RIGHT OF WAY AGREEMENT.

This agreement, made and entered into on this 2nd day of April, 1924, by and between D. D. Wamsley and Margaret Wamsley, hereinafter called the gra-ntor, and Oklahoma Natural Gas Company, hereinafter called the gratee.

Witnesseth, that said granter for and in consideration of the sum of \$20.00 dollars to him in hand paid by said grantee, the receipt of which is hereby acknowledged, and for and in consideration of the agreements and covenants hereinafter contained, does hereby grant to the said grantee, the right of way to lay, maintain, operate, relay and remove a pipe line 80 rods long, and located in accordance with plat of definite location on the back thereof, for the purpose of the transportation of Narural Gas, with right of ingressand egress to and from the same, on, over and through certain lands situated in the County of Tulsa, State of Oklahoma, described as follows, to-wit:
