

1. That the said grantor is to fully use and enjoy the said premises, except the easement for the purpose hereinbefore granted to said grantee.

2. That said grantee hereby covenants to bury its lines of pipe so that the same will not interfere with the cultivation of said premises.

3. That the grantee shall have the right at any time to change the size of its line of pipe.

4. That the grantee shall pay all damage to fences, crops and premises, which may be suffered by reason of laying maintenances or alteration of said lines of pipe. If not mutually agreed upon, said damages are to be ascertained and determined by three disinterested persons, one thereof to be appointed by the owner of the premises, one by the grantee, and the third by the two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive.

This contract shall bind and run in favor of the respective parties hereto, their heirs, executors, administrators, successors and assigns.

RIGHT OF WAY AGREEMENT.

This agreement, made and entered into on this 6th day of May, 1924, by and between Claude Sample, hereinafter called the grantor, and Oklahoma Natural Gas Company, hereinafter called the grantee.

Witnesseth that said grantor for and in consideration of the sum of forty & no/100 dollars to him in hand paid by said grantee, the receipt of which is hereby acknowledged, and for and in consideration of the agreements and covenants hereinafter contained, does hereby grant to the said grantee, the right of way to lay, maintain,
