AGREEMENT AND DECLARATION OF TRUST.

This agreement, made and entered into this 9th day of May, 1924, by and between Don W. Walker, Homer D. Key and W. G. Baker, of Sapulpa, Oklahoma, as subscribers, and W. G. Baker of Sapulpa, Oklahoma, as Trustee.

Witnesseth: That whereas, the subscribers propose or purchase that certain gasoline plant now and heretofore owned by Leota Gasoline Company, a corporation, and located on the following described real property situate in Tulsa, Tulsa County, Oklahoma, to-wit:

The southeast quarter (SE $\frac{1}{4}$) of section fourteen (14) township sixteen (16) north range twelve (12) east, together with all supplies, material and equipment belonging and appertaining thereto; and all of the right, title, interest and estate of said Leota Gasoline Company, a corporation, in and under a certain lease contract entered into between J. W. Chadwick and Louis Bendit, co-partners doing business as Chaswick & Bendit, as lessee, and the Minnehoma Oil Company, a corporation, as lessor, and under the assignment of said lease contract by the said co-partnership of Chadwick & Bendit to said Leota Gasoline Company, a corporation, and do propose after the purchase of said plant and lease contract as aforesaid to conduct and operate said plant on the aforescribed real property under the said lease contract with the said Minnehoma Oil Company; and do propose as aforesaid to take the title to said plant and equipment and to the interest of the lessees in said contract in the name of W. G. Baker, Trustee of Ardis Gasoline Company, and the said Trustee for the purpose of defining the interest of subscribers and the assigns in such property have agreed to issue to the subscribers negotiable certificates representing beneficial interests or shares in and to the trust estate herein created, to the amount of one hundred (100) common beneficial interests of no par value and non-assessable, and which are transferrable on the books of the trustee in accordance with the terms of this account.

Now, therefore, the said trustee does hereby declare that he will hold said property to be transferred to him as aforesaid as well as all other property which he may acquire as trustee together with the proceeds and profits thereof, in trust, to manage and dispose of the same for the benefit of the holders from time to time of certificates issued herewith and in the manner and subject to the stipulations herein contained, to-wit:
