The southwest quarter (SW $\frac{1}{4}$) of the southwest quarter (SW $\frac{1}{4}$) (also known as lot seven (7) section six (6) township fifteen (15) north, range ten (10) east,

said lease being recorded in the office of the County Clerk in and for Creek County in book 221, page 423, and transferred by mesne assignments to the mortgagors herein; together with all the personal property now being used or which was obtained in connection with the said lease at that time.

This mortgage is given to secure the payment of the sum of fifty thousand (\$50,000.00) dollars, with interest ^{thereon} at the rate of eight per centum (8%) per annum, according to the terms of two promissory notes, of even date herewith, described as follows, to-wit: One note for the sum of thirty thousand (\$30,000.00) dollars, due in sixty days (60) from the date thereof, in favor of the Commercial National Bank of Muskogee, bearing interest after maturity, at the rate of eight per cent (8%) per annum, and one note for the sum of twenty thousand (\$20,000.00) dollars, due in sixty (60) days from the date thereof, in favor of the Muskogee National Bank of Muskogee,
