RIGHT OF WAY GRANT.

In consideration of thirty & no/100 dollars this day paid toMrs. Delia Hastingem by Cosden Pipe Line Commony, receipt wh eroof is hereby acknowledged, do hereby grant and convey unto said Cosden Pipe Line Comany, its successors and assigns, right to locate, maintain and operate a pipe line for the purpose of conveyance of oil over, through, and upon that certain tract of land situated in Tulsa Couty, and the described: north 15 acres, SE-4, SE-4, 29-19-12, 10 inch oil line, to run through same, 30 ro ds.

Also there is hereby granted a right to erect and maintain a telephone and telegraph line. The rights herein granted shall perm it the use of suchland as may he necessary for said pipe line and for said telegraph and telephone line, and shall also permit the grantee herein, its successors or and assigns, to do whatever may be necessary to their construction or for the enjoyment of the rights herein granted, including the right of ingress and egress to and from said tract of land, for the purpose of laying, maintaining, repairing and restoring of said pipe line and said telegraph and telephone line, and for removing the same when desired by the grantee; its successors and assigns.
