and by her attorneys, Turner, Turner, Harley & Pattis, and no one appearing to object to the confirmation of said sale; and it appearing that said sale was made under an order of this Court authorizing the same, which said Order we made and entered on the 29th day of January, 1924, and is hereby referred to for further particulars and that inntice was given of said sale and of the hearing of said return as required by law and by the orders of this Court: And the Court having examined said Return, and having heard and considered the evidence of witnesses of fored in support of said return, and being welland sufficiently advised in the premises, finds;

That said sale was legally made and fairly conducted, and that notice of the time, and place and terms of said sale was duly given in manner and form as required by law and by Order of this Court.
