- Assignment of this lease or any interest therein may be made with the approval 11: of the Secretary of the Interior; it being understood that to secure such approval the proposed assignee need only bg qualified to hold such a lease under the rules and regulations, and furnish a bond with responsible surety to the stisfaction of the Secretary of the Interior, conditioned for the faithful performance of thecovenants and conditions of this lease.
- 12. In event restrictions on alienation shall be removed from all the leashold premiæs described above, this lease shall be released from the supervision of the Secretary of the Interior, such lease to take effect without further agreement from the date such restrictions are removed, and thereupon the authority and power delegated to the Sectary of the Interior as herein provided shall cease, and all payments required to be made to said Surerintendent for the Five Civilized Tribes, Muskogee, Oklahoma, shall thereafter be made to lessor or to the then owner of said lands in person or be deposited to the credit of said lessor or his assigns at Guaranty State Bank of Sand Springs, O.K. or such other place as the said lessor or his assigns may from time to time designate in writing, and changes in regulations thereafter made by the Secretary of the Interior applicable to aid and gas lease shall not apply to this lease.
- 13. Each and every clause and covenant in this indenture shall extend to the heirs, executors, administrators, successors and lawful assigns of the parties hereto.
