

Now, therefore, for and in consideration of the sum of one dollar, (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, the said N. T. Gilbert, C. H. Nash, and T. J. Hartman, (the said C. H. Nash being the successor of the said C. H. Seger) acting for and on behalf of the said Producers National Bank of Tulsa, Oklahoma, do hereby release unto the said F. A. Gillispie, his heirs, personal and legal representatives and assigns, said lease and said Supplemental Agreement of Lease, insofar as the same cover the following described tracts and parcels of land located and situated in Tulsa County State of Oklahoma, to-wit:

All that part of lot 7 in block 104 of the Original Town, now City of Tulsa, described as follows:

Beginning at a point eighty (80) feet westerly and at right angles to a point on the east line of lot 7 of block 104 of the original Town, now City of Tulsa, and fifty five (55) feet northerly from the southeast corner of said lot; thence northerly parallel with the east line of said lot twenty (20) feet; thence easterly parallel to the south line of said lot five and one half inches ($5\frac{1}{2}$); thence southerly parallel with the east line of said lot twenty (20) feet; thence easterly parallel with the south line of said lot five and one half ($5\frac{1}{2}$) inches to the place of beginning.

And also that part of lot 7 in block 104 of the Original town, now City of Tulsa described as follows: to-wit:

Beginning at a point seventy five (75) feet westerly and at right angles to a point on the east line of lot 7, of block 104, of the original town now City of Tulsa, Oklahoma, and fifty feet northerly from the southeast corner of said lot; thence northerly parallel with the east line of said lot ^{five (5) feet} thence westerly parallel with the south line of said lot five (5) feet, five and one half ($5\frac{1}{2}$) inches, thence southerly parallel with the east line of said lot five (5) feet; thence easterly parallel with the south line of said lot five feet; five and one-half ($5\frac{1}{2}$) inches to the place of beginning.

together with all improvements thereon and the appurtenances thereunto belonging; and for the same consideration, do hereby quit claim remise, re-convey and release said tract of land and improvements thereon and appurtenances thereunto belonging, unto the said F. A. Gillispie, his heirs, personal and legal representatives and assigns.
