And the court having hear the evidence and being advised in the premies finds that proper notice to creditors to precent claims against this estate has been given by posting and by publication as provided by law and in proper form farning creditors that claims not presented within four ments of the date of the notice would be forever barred, and that proper proof of the posting and the publication of such notice is not on file in this case and the time for presenting claims against the estate has expires and that no claims remain unpaid.

And the court further finds that by written agreement and stipulation entered into by and between Edgar Buffington and Incien Buffington Wyly and Jame Anna Phillips, the devisces under the will of peccedent, and upon a sufficient consideration by mutual distribution provided for each devises, a partial distribution of the estate is arranged for, and such agreement is approved by the court and adopted as a guide to the distribution of said estate.

It is therefore considered, adjudged and decreed that the devisee, Jane Anna Phillips, have and receive of and from the estate of Nancy G. Buffington, as such devisee, and in her own right free from the claims of heirs and devisees of the decedent, and of the other devisees and all other persons, and free from the claims of creditors of the decedent, and of the costs of administration of theestate, all the following described real estate, to wit:
