WITNESSETH, The said party of the first part, in consideration of the sum of Seventy-five and No/100 DOLLARS the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell and convey unto the said party of the second part, his heirs and assigns, all of the following described real estate situated in the County of Tulsa, and State of Oklahoma, to-wit:

An undivided half interest in Lot Thirty-seven (37), of Block Seven (7),  
of North Tulsa View Subdivision,

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining forever.

And said RESOURCE DEVELOPMENT COMPANY, for its successors and assigns does hereby covenant, promise and agree to and with said party of the second part, that at the delivery of these presents, it is lawfully seized in its own right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincumbered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever; reserving, however, mineral rights, and that it will warrant and forever defend the same unto said party of the second part his heirs and assigns, against said party of the first part, its successors and assigns, and all and every person whomsoever, lawfully claiming or to claim the same.
