THIS INDENTURE Made this 20 day of April, 1923, by and between R. D. Sanford, as sheriff of the county of Tulsa in the state of Oklahoma, party of the first part and M. V. Kennell, of the county of Tulsa, party of the second part, WITNESSETH:
