after called assignor, is desirous of assigning an undivided 1/4 interest in and to his 7/128

WHEREAS, the said assignor hereinbefore named also claims that the oil and
gas mining lease hereinbefore referred to owned by him also covers the additional property,

Approximately 30 acres of land adjacent to and adjoining Lot Five (5), of
Section 24, in Township 17 North, or Range 14 East, of the Indian Meridian,
in Tulsa County, Oklahoma, and extending to or into the river bed of the
Arkansas River,

and

in and to the 7/8 working interest.
WHEREAS, the assignor claims to own an undivided 7/64 interest of said oil and
gas mining lease insofar as it pertains to the property last above described, and is desirous
of assigning to the assignee herein, Roy F. Ford, an undivided 1/4 interest in and to his
undivided 7/64 interest in and to the 7/8 working interest in and to the property last above
described,

good and valuable considerations paid to the assignor by the assignee herein, the receipt of
which is hereby acknowledged, the assignor does hereby, and by these presents, assign, sell,

and to his undivided 7/64 interest in and to the 7/8 working interest in the oil and gas
mining lease covering the property last above described.

IT IS EXPRESSLY UNDERSTOOD AND AGREED by and between the assignor and the
assignee herein that this assignment is to include the respective undivided interests in and
to all wells, rigs, pipes, powers, materials, equipment, appurtenances and paraphernalia of
any kind whatsoever situated on the foregoing described premises, and the proportionate un-
divided interest in and to all the oil produced and saved from said premises from 12 o'clock
noon on the 30th day of June, 1919.
