COMPARED NOW, THEREFORE, conditioned upon the approval of the Department of the Interior, it is stipulated and sgreed that, in lieu of a separate test of casinghead gas produced from the lands covered by the said agreement of the 21st day of March 1918, there shall be one test made at the plant of party of the second part, which said test shall be taken from the discharge side of the vacuum pump at said plant, and that the gasoline content as determined by the said test shall, for the purposes of said agreement, constitute the gasoline content of the gas taken from the lands described therein. The time, manner and method of making the said test, however, shall, in all other respects, be the same as is prescribed in the said agreement of the 21st day of March, 1918, and nothing herein contained shall be construed to change, alter or modify said agreement, except in the particular above specified.
