I, T. D. Evans, being first duly sworn on oath say that I am the person who executed the quitolaim Deed from myself to Horses Speed which deed is dated July 24th, 1922 and filed for record July 27th, 1922 and duly recorded in book 387, page 327; records of Tulsa County, Oklahoma.

This said deed conveys an undivided two-third (2/3) interest in and to the land above described. In said deed a recital is made of a mortgage of \$1675.29 dated July 24th., 1922 made by T. D. Evans, which mortgage is described as being executed but not recorded. At this time, July 24th, 1922, the above described land had been conveyed to myself, and the entire fee was owned by Horace Speed, J. S. Hopping and myself. Horace Speed owned an undivided 2/3 interest, J. S. Hopping an undivided 1/6 interest and myself an undivided 1/6 interest. We calculated that to make full settle ment for this land required this sum, \$1675.29 and I drew a mortgage for that amount which was never delivered. Another adjustment was made immediately after the mortgage was drawn whereby J. S. Hopping and myself paid our share in cash and Horace Speed adjusted his portion by a mortgage of \$1100.00 which is found duly of record against an undivided 2/3 of the land above described. The said mortgage was torn up and was never used and is not now in existance It never left the office of Hopping & Evans. The record title to this land described above
