KNOW ALL MEN BY THESE PRESENTS That whereas the city of Tulsa, Oklahoma, municipal corporation, by Ordinance No. 2321 passed and approved on July 7, 1922, did create Sewer District No. 184, and define the same so as to included all of Blocks One (1) and Two (2) of Elmwood Addition to said City of Tulsa, and a system of sewers has been constructed in said sewer district under a contract let by said city to C.O. and H. Frye, which sewers serve all of the property in said district except Lots, 1,2,3,14,15 and 16 of said Block No. 1, which lots cannot be served thereby, and,

WHEREAS, By Ordinance No. 2358, of said city passed and approved the 19th day of December, 1922, the cost of constructing said sewers has been assessed against all the lots in said Elmwood addition except said six lots in Block One (1) thereof, and;

WHEREAS, C. D. Coggeshall is the owner of all of the lots in said Block One (1) except Lots Four and Five and is the owner of all of the lots in said Block Two (2) except Lots Six and Seven and Eight and the following persons are the owners of the lots in said addition which are hereinafter described and set opposite their respective names, to-wit:
