230838 C. J. ASSIGNMENT OF OIL AND GAS LEASE COMPARED

Whereas, on the 3rd day of March 1923, a certain oil and gas mining lease was made and entered into by and between Xenophon Jones and J. B. French & Co. Inc. covering the following described land in the county of Tulsa and State of Oklahoma, to-wit:

WHEREAS, The said lease and all rights thereunder or incident thereto are now owned by -----

NOW, THEREFORE, For and in consideration of One Dollar (and other good and valuable considerations, the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, do hereby bargain, sell transfer, assign, and convey unto W. D. Maples of the right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sec 6, Twp. 16 N. R 14 E. together with all personal property used or obtained in connection therewith to W. D. Maples and his heirs, successors and assigns.

And for the same consideration, the undersigned for them and Their heirs, successors and representatives, do covenant with the said assignee, his heirs, successors or assigns that are the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.

IT IS EXPRESSLY AGREED and made a part of this assignment that the rentals of one dollar per each acre herein assigned and transferred must be paid into the office of the undersigned on or before the -----day of -----19-----, and for each successive and annual date during the original term of the lease unless oil or gas is produced and marketed in paying quantities from said original lease and failure to pay said rental as aforesaid shall cancel and annul this assignment and all rights herein conveyed shall revert back to the undersigned assignor.
