RESOLUTION

COMPAKED

WHEREAS, on the 24th day of February, 1917, Chas. Page of Sand Springs, Oklahoma, executed to the Board of Education of School District Number 19, a Quit Claim Deed, conveying to it, for use for school purposes, the following described real estate and premises, situate in Tulsa County, State of Oklahoma, to-wit:

Beginning at a point on the East line of Lot Two (2) or the Southwest Quarter (SW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) Fractional Section Seven (7) Township 19 North, Range 12 East, Six Hundred Eighty-one and Five-tenths (681.5) feet north of the Southeast corner of said Lot Two (2) of said Fractional Section 7, thence West at right angles to said East line a distance of Two Hundred Sixty-four (264) feet; thence North parallel to said East line a distance of One Hundred Eighteen and two-tenths (118.2) feet; thence North Seventy degrees (70) East a distance of Two Hundred Eighty and six-tenths (280.6) feet to and intersecting the East line of said Lot two (2); thence South on and along the East line of said Lot Two (2) a distance of Two Hundred Thirteen (213.5) and five-tenths feet to the point of beginning; All situated in Lot Two (2) of the Northeast Quarter (NE $\frac{1}{4}$) of Fractional Section 7, Township 19 North, Range 12 East, Tulsa County, Oklahoma, containing one Acre (1), more or less, and

WHEREAS, the Board of Education of School District Number 19, has deemed it for the best interests of said School District, and has heretofore resolved upon changing the location of the school house to the following described real estate and premises, situate in Tulsa County, State of Oklahoma, to-wit:

All of Block Three (3) of Second Lake Sub-Division of Lot Two (2) of Section Seven (7), Township Nineteen (19) North, Range Twelve (12) East, according to the recorded plat thereof, situate in Tulsa County, State of Oklahoma, and,

WHEREAS, the said Chas. Page, owner of the real estate and premises herein last described, has offered to Quit Claim said last above described real estate and premises to the Board of Education of School District Number 19, Tulsa County, Oklahoma, for use for school purposes only, in exchange for a Quit Claim Deed from the Board of Education of School District Number 19, Tulsa County, State of Oklahoma, conveying to the said Chas. Page, the real estate and premises first hereinabove described.

NOW THEREFORE, Be it Resolved, by the Board of EDUCATION of School District Number 19, Tulsa County, Oklahoma, in regular meeting assembled, that said proposition of Chas. Page be accepted, and that he having executed a Quit Claim Deed conveying to said Board of Education, real estate and premises herein last above described, that Board of Education of School District Number 19, Tulsa County, State of Oklahoma, execute to the said Chas. Page, a Quit Claim Deed conveying to him the real estate and premises herein first above described, and
