Tulsa, thence north 19.5ft. thence in an easterly direction 100.5 ft. to a point on the  $\pm 50$  . South line of said lot 98.5 ft. from the point of beginning, theme west along the south line of said lot, to the point of beginning.

We further report that the CITY OF TULSA, OKLAHOMA, the plaintiff in the above cause, has found it necessary to take for street purposes a portion of Lot 1. Block 6. and that said City be granted said territory.
