

tition for such determination of heirship having been filed by Rosa May DeLong, mother of Esta Irene Welling, deceased, and one of the heirs of the said Esta Irene Welling, and the court having taken the evidence in said cause and being fully advised in the premises, FINDS,

COMPARED

That Esta Irene Welling, deceased, was and had been for more than five years prior to her death, a resident of Tulsa County, Oklahoma; that said Esta Irene Welling died in the City of Tulsa, County of Tulsa, State of Oklahoma on the 27th day of August, 1921.

That at the time of the death of the said Esta Irene Welling she left surviving her a husband Frank J. Welling who was then a resident of Tulsa, Tulsa County, Oklahoma, but who is now residing at the town of Virgil, State of Kansas and has resided there for more than one year last past and received his mail at the town of Virgil, State of Kansas; a mother Rosa May DeLong who is now and for more than five years last past has been a resident of Tulsa, Tulsa County, Oklahoma, residing at 1647 East Second Street, Tulsa, Tulsa County, Oklahoma, ; a father John B. Moreland who is now and for more than two years last past has been a resident of New Orleans, State of Louisiana, residing at 618 South Street, in said City of New Orleans.

That the said Esta Irene Welling, deceased was married to Frank J. Welling, at Tulsa, Tulsa County, Oklahoma on the 11th day of September, 1920; that there were no children born of said marriage; that the said Esta Irene Welling, deceased has not given birth to any children whatsoever; that the marriage of the said Esta Irene Welling, deceased, and the said Frank J. Welling, was the first and only marriage of the said Esta Irene Welling.

That at the time of the death of the said Esta Irene Welling deceased, she left an estate of One Hundred fifty (\$150.00) Dollars cash in the Exchange National Bank of Tulsa County, Oklahoma, an undivided one-fourth interest in a set of drilling tools of the appraised value of about one Thousand (\$1,000) Dollars and an equity in the following described real estate;

The East fifty-five feet (55) of the North One Hundred (100) feet of Lot Six (6), Block , Eleven (11), Highlands Addition to the City of Tulsa, as per the recorded plat thereof, all situate in the City of Tulsa, County of Tulsa, State of Oklahoma.

That the said Esta Irene Welling owned said property in fee as her personal property, subject however to a first mortgage of twenty-five hundred (\$2500) Dollars to the Aetna Building and Loan Association and a second mortgage of Fourteen Hundred (\$1400) Dollars to Davenport & Ratcliffe Loans and Insurance, Tulsa, Oklahoma.

The court further finds that there was no other property real or personal belonging to the estate of the said Esta Irene Welling, deceased, or any right, title or interest in and to any property either real or personal belonging to the estate of Esta Irene Welling, deceased, except as above noted.

The court further finds that the petition for determining heirship herein in said County court of Tulsa County, Oklahoma being probate No. 3868, was filed on March 17, 1923, and the hearing therein set for May 10, 1923 at nine o'clock A. M. at which time the court being engaged in other business and there being no objections, said hearing was continued to May 21, 1923 at nine o'clock A. M. at which time the court being engaged in other business and there being no objections thereto, said hearing was continued until May 28, 1923 at two o'clock P. M. at which time said cause came on regularly for hearing as herein provided.

The court further finds that a copy of said summons was by registered mail delivered to Frank J. Welling at Virgil, Kansas and that the said Frank J. Welling did accept personal service of said summons on the 27th day of March, 1923, at Virgil, Greenwood County,
