The court further finds that Frank J. Welling is a legal and lawful heir of Esta Irene Welling, deceased, entitled to an undivided one-half interest in and to the real estate belonging to the said Esta Irene Welling, deceased, hereinbefore described.

The court further finds that Ross May Delong was the mother of Esta Irene Welling, deceased; that the said Ross May Delong is now and for more than five years last past has been a resident of Tulsa County, and now resides at 1647 East Second Street, Tulsa County, Oklahoma; that the said Rosa May Delong appeared in court in person at this hearing and by her attorney, Frank E. Duncan; that the said Rosa May Delong is a lawful and legal heir of the said Esta Irene Welling, deceased, and is entitled to an undivided one-fourth interest in and to said real estate as the heir of the said Esta Irene Welling, deceased.

The court further finds that John B. Moreland whose residence is as herein set forth, is the father of the said Esta Irene Welling, deceased and as such is a lawful and legal heir of Esta Irene Welling, deceased, and is entitled to an undivided one-fourth interest in and to said real estate hereinbefore set out; that the said John B. Moreland has been served with notice of this action by registered mail to his address at 618 South Street, New Orleans, State of Louisiana and that the said John B. Moreland has filed in this cause a verified acceptance of summons and copy of petition and waiver of notice and disclaimer of interest therein.

The Court further finds that service was had upon the heirs, executors, administrators, devisees, trustee and assigns immediate and remote who were unknown to the petitioner herein, by publication in manner and form provided by law; that said publication notice was filed in this cause on March 12, 1923, and made a party of the pleadings and proof in said cause and that said publication notice was published in the Tulsa Daily Legal News for three consecutive weeks, the first publication being on the 22nd day of March, 1923, and the last publication being on the 12th day of April, 1923, and the proof of publication together with a copy of said publication notice was verified by Jennie C. Rosen who is the editor and publisher of the said Tulsa Daily Legal News, and that the same was filed in this cause April 13, 1923, and made a part of the pleadings and proof herein.

The court further finds that there has been no objections or appearance filed herein except the appearance of the said Rosa May Delong, the said John B. Moreland and the said Frank J. Welling, as herein set forth.

The court further finds that the said Esta Irene Welling, deceased, died intestate without any will or legal disposition of her property.

The court further finds that Frank E. Duncan is the duly and legally appointed administrator of the estate of Esta Irene Welling, deceased; that the said Frank E. Duncan was present in person as such administrator at the hearing herein and made no objections to the evidence or the findings of the court herein.

NOW THEREFORE IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the sole and only heirs of the said Esta Irene Welling, deceased, are Rosa May DeLong, the mother of Esta Irene Welling, deceased, who is a resident of Tulsa, Tulsa County, Oklahoma, and entitled to an undivided one-fourth interest in and to said estate of Esta Irene Welling, deceased; John B. Moreland, the father of Esta Irene Welling, deceased, who is a resident of New Orlean, Louisiana, entitled to an undivided one-fourth interest in and to said estate of Esta Irene
