(o) All of the following described lots, tracts and parcels of land lying and being situated in the City of Shawnee, County of Pottawatomie, State of Oklahoma, viz:

1. Lots eight and nine, in block seventy-four as shown by the amended plat of Shawnee, Oklahoma. Also that portion of lot numbered six in block thirty-seven as shown by said amended plat, said part of said lot six being more fully described as follows: Commencing at a point fifty feet east of the northwest corner of said lot thence east one hundred feet along the north line of said lot six, thence south forty-eight feet, more or less, the width of said lot six thence west one hundred feet along the south line of said lot six, thence north forty-eight feet, more or less, the width of said lot six, to the place of beginning.

2. Also the north one-half of lot five, block thirty-seven, twenty-four feet wide, one hundred and fifty feet long, as shown by amended plat of Shawnee, Oklahoma, together with all improvements thereon and appurtenances thereunto belonging.

3. Also commencing at the southeast corner of lot number seven in block number seventy-four, thence west ninety feet thence north to a point due west of the north line of lot number six in block number thirty-seven thence east to a point due north of the east line of lot number seven in block seventy four, thence to the point of beginning; all in the city of Shawnee as shown by the amended plat thereof, together with all the improvements thereon and appurtenances thereto belonging.

(p) All of the following described lots, tracts and parcels of land lying and being situated in the City of Houston, County of Harris, and State of Texas, viz:

All of those certain lots, tracts and parcels of land lying and being situated on the north side of Buffalo Bayou and south side of White Oak Bayou in the City of Houston, in Harris County, Texas and more particularly described as follows:

1. A tract of land in the John Austin two leagues grant, beginning for southeast corner at northwest corner of block 318 of the Shearn Addition to Houston, at the North end of the east line of Henderson Street; which beginning point is 182.5 feet north of the center of Spring Street and on the north line of the shearn Addition to Houston and from said beginning point run thence north five hundred and sixty-six feet along what would be the east line of Henderson Street if extended, to a point for northeast corner on the south line of the land conveyed by Rachel B. and Charles Stewart to David Ehrhardt, by deed recorded in volume 12, page 510, of Harris County Deeds Records; thence at right angles west 510 feet to a point for northwest corner; thence at right angles south 566 feet to a point in the north line of block 334 of the Shearn Addition; thence east along the north line of the Shearn Addition 510 feet to the place of beginning and including approximately six and sixty-two one-hundredths acres and being a part of the land conveyed by Rachel B. Stewart to Geo. H. Hermann by deed dated December 29, 1906, and recorded in volume 237, page 448, of Harris County Deed Records.

2. Also all of block three hundred and thirty-three of the Shearn Addition to the City of Houston, in Harris County, Texas, which Addition is a subdivision of lot number nineteen of the Hollingsworth survey or sub-division in the John Austin two leagues grant and which block 333 contains six lots each of which is 50 feet front by 147.5 feet deep, and said block is bounded east by Henderson Street and is bounded west by Hemphill Street and is bounded south by Spring Street and is bounded north by the south line of the First Tract described in this deed.

3. Also block number three hundred and thirty-four of the Shearn Addition to the City of Houston, in Harris County, Texas, which Addition is a subdivision of lot number nineteen of the Hollingsworth survey or sub-division in the John Austin two leagues grant and which block 334 contains six lots each of which is 50 feet front by 147.5 feet in depth, and said block 334 is bounded east by Hemphill Street and
