

UNDER LEASE NO. 4: COMPARED

All of Section 7 of Township One (1) North, Range Eleven (11) East, and the East 1/2 of Section 12 of Township One (1) North, Range Ten (10) East, of the Indian Meridian, and containing Nine hundred and sixty acres, more or less.
