AGREEMENT, Made and entered into 7th day of April 1923 by and between Sevier Dudley (formerly Sevier Bean ) and her husband Bert Dudley Party of the first part, hereinafter called lessor (whether one or more) and Leon Baker and E. E. Oberholtzer parties of the second part, hereinafter called lesses, ------, party of the second part, lesses.

WITNESSETH, That the said lessor, for and in consideration of Eighty DOLLARS cash in hand paid, receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and laying pipe lines, and building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa State of Oklahoma, described as follows, to-wit:

The south half of the southeast quarter ( Said land being no part of a homestead) of Section 15 Township 21 N/Rmge 13 E. and containing Eighty acres, more or less.

It is agreed that this lesse shall remain in force for a term of five years from date, and as long thereafter as oil or gas, or either of them, is produced from said land by the lessee.

In consideration of the premises the said lessee covenants and agrees:

lst. To deliver to the credit of lessor, free of cost, in the pipe line to which he may connect his wells, the equal one-eighth part of all oil produced and saved from the leased premises.

2nd. To pay lessor for gas from each gas well where gas only is found, the equal one-eighth (1/8) of the gross proceeds at the prevailing market rate for all gas used off the premises, said payments to be made at the American National Bank of Enid, Oklahoma and
