MEMORANDUM OF AGREEMENT, Made and entered into in duplicate this the 11th day of May 1923, by and between CLEVES F. BRUCE and JULITA G. BRUCE, his wife, of Tulsa, Oklahoma, of the first part, and FRANK C. GIDDINGS, a single man, of Tulsa, Oklahoma, of the second part.

WITNESSETH: WHEREAS, the parties of the first part are the owners of the following described tract of land, numbered 1, situate in the City of Tulsa, Tulsa County, Oklahoma, to-wit:

TRACT 1. The East 140 feet of Lots 1 and 2, in Block 1, in Seig Addition to the City of Tulsa, according to the recorded plat thereof.

AND, WHEREAS, the party of the second part is the owner of the following described tract of land, numbered 2, situate in the City of Tulsa, Tulsa County, Oklahoma, being a portion of said Lots 1 and 2, in Block 1, in said Seig Addition, to-wit:

TRACT 2. Commencing at a point on the North Line of Said Lot 1, in Block 1, Seig Addition, 140 feet West of the Northeast Corner of said Lot 1; running thence due West along the Northerly lot line of said Lot 1, a distance of 28 feet; thence South and parallel with the Easterly Lot line of said Lots 1 and 2, a distance of 100 feet; thence East and parallel with the Northerly lot line of said Lot 1, a distance of 28 feet; thence North to the place of beginning.

AND, WHEREAS, it is desired that the Westerly eight (8) feet of said tract numbered 1, together with the Easterly Eight (8) feet of said Tract Numbered 2, shall be reserved for use by the parties hereto as a private alley way.

NOW, THEREFORE, in consideration of the mutual promises and agreements herein contained and the performance thereof by the parties hereto, as hereinafter specified, it is stipulated and agreed as follows, to-wit:
