That I am past eighteen (18) years of age, and unmarried; that on the 18th, day of April 1919, Mary L. Baughman, as the guardian of the undersigned, executed to Clark F. Bryan and B. W. Ludeman an oil and gas lease covering said real estate and premises, recorded in Book 243, at Page 659, That afterward said lease was assigned by said lessee to various persons, as shown by the records of the County Clerk of Tulsa County, State of Oklahoma, and that the interest of all lessees and assignees has been released of record, except one assignee, to-wit: J. Alex Dingwall, Jr., who received an assignment covering a portion of said real estate and premises, which is recorded in Book 289, at Page 612, in the office of the County Clerk of Tulsa County, State of Oklahoma. That no oil and gas has ever been produced by said lessee or by any person whomsoever, from said real estate and premises, and that neither the undersigned nor the said guardian of the undersigned, Mary L. Baughman, has received any rentals from said lessees or any of them since the undersigned became 18 years of age, and that said real estate and premises is at this date not encumbered by any oil or gas mining leases whatsoever, except the lease dated April 28, 1923, which the undersigned has recently executed to one, Samuel N.
