WHEREAS, The said Commission to the Five Civilized Tribes, or its lawful successor, has certified that the land hereinafter described has been selected by or behalf of William Ellick a citizen of said tribe, as an allotment, exclusive of land equal in value to forty acres of the average allot table lands of the Cherokee Nation, selected as a homestead as aforesaid,

NOW , THER FORE, I the undersigned, Principal Chief of the Cherokee Nation, by virtue of the power and authority vested in me by aforesaid Act of the Congress of the United States, have granted and conveyed, and by these presents do grant and convey unto the said William Ellick all right, title and interest of the Cherokee Nation, and of all other citizens of said Nation, ina nd to the following described land, viz;

> Lot Three (3) of Section Four (4) and Lot One (1) of Section Five (5) and the West Eight and 52/100 (8.52) acres of Lot Four (4) of Section Six (6) and the East Ten and 49/100 (10.49) acres of Lot Three (3) of Section Two (2) Bownship Nineteen (19) North, Range Fourteen (14) East.

of the Indian B se and Meridian, in Oklahoma, containing Sixty and 18/100 (60.18) acres, more or less, as the case may be, according to the United States survey thereof, subject however, to all the provisions of said Act of Congress.
