WHEREAS, NANNIE E. CHAMBERS, a citizen of the C H E R O K E E Nation was allotted certain land, which land is restricted against alienation.

Now, Therefor, I, under the authority vested in me by the Act of Congress Epproved May 27, 1908, (35 Stat. L. 312) and the regulations of the Department prescribed thereunder, hereby remove, without conditions concerning terms of sale and disposal of proceeds, the restrictions on alienation of all the restricted allotted lands of said Indian allottee and the restrictions on the alienation of all land purchased for the benefit of said Inidan allottee, with funds held under the control of the Secretary of the Interior, which lands were, by the terms of the deed of conveyance, impressed with restrictions on alienation, such removal of restrictions to be effective thirty days from date hereof. TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS, a townsite commission, heretogere appointed and acting under authority of the Act of Congress approved March 1, 1901, (31 Stat., 861,), agreement ratified by the Creek Nation May 25, 1901, has appraised the lots in the town of Tulsa, Muskogee (Creek) Nation, Indian Territory; and

WHEREAS, the plut of said town was approved by the Secretary of the Interior on the lith day of April 1902 and was duly placed on file; and

WHEREAS, said commission has appraised all of the town lots included insaid plat at their true value, excluding improvements, which appraisal has been approved by the Secretary of the Interior; and

WHER AS, the said commission has awarded the real estate described hereinbelow to EDWARD L. LOVE, who has paid THIRTY-FIVE (\$35.00) Dollars, the full amount of the purchase price, into the treasury of the United States, to the credit of the Muskogee or Creek Nation of Inidans, with the United States Indian Agent at Muskogee, Indian Territory and is, therefore, entitled to appatent;

NOW, THEREFORE, I, the undersigned, the Principal Chief of the Muskogee Creek) Nation, do, by virtue of the power and authority vested in me by the aforesaid Act of Congress of the United States, hereby grant, sell, and convey unto the said EDWARD L. LOVE, his heirs and assigns, forever, all the right, title, and interest of the Muskogee (Creek) Nation, aforesaid, in and to Lots Numbered (1) and (2) in Block numbered (94) in the Town of Tulsa, Muskogee (Creek) Nation, Indian Territory, and according to th e plat thereof on file as aforesaid.

IN WITNESS WHEREOF, I, the Principal Chief of the Muskogee (Creek) Nation have hereunto set my hand and caused the Great Seal of said Nation to be affixed at the date hereinafter shown.
