SCAPPARED WHEREAS, a townsite commission, heretofore appointed and acting under authorit y of the Act of Congress approved March 1, 1901 (31 Stat., 861) Agreement ratified by the Creek Nation May 25, 1901 has appraised the lots in the town of Tulsa, Muskoges (Creek) Natio n Indian Territory: and

WHEREAS, the plat of said town was approved by the Secretary of the Interior on the 11th day of April 1902, and was duly placed on file; and

WHERFAS, said commission has ap raised all of the town lots included in said plat at their true value, excluding improvements, which ap raisal has been approved by the Se cretary of the Interior; and

WHEREAS, the said commission has awarded the real estate described hereinbel ow to EDWARD L. LOVE, who has paid THIRTY-FIVE (\$35.00) Dollars, the full amount of the pur chase price, into the treasury of the United States, to the credit of the Muskogee, or Creek N ation of Indians, with the United States Indian Agent, at Muskogee, Indian Territory, andis, therefore, entitled to a patent:

NOW, THEREFORE, I, the undersigned, the Principal Chier of the Muskogee (Creek) Nation, do, by virtue of the power and authority vested in : me by the aforesaid Act of t he Congress of the United States, hereby grant, sell, and convey unto the said EDWARD L. LOV E, his herrs and assigns, forever, all the right, title, and interest of the Muskogee (Cr eek) Nation, aforesaid, in and to lots numbered [1] and (2) in Block numbered (94) in the Town of Tulsa, Muskogee (Creek) Nation, Indiana Territory; and according to the plat thereof on file as aforesaid.

IN WITNESS WHEREOF, I, the Principal Chief of the Muskogee (Creek) Nation, have hereunto set my hand and caused the Great Seal of said nation to be affixed at the date hereinafter shown.
