This cause coming on for hearing on petition of the administratrix herein for an order of final distribution and decree of heirship in the above styled cause, and after a full hearing hereon, and due consideration by the court, and the court being fully advised in the premises, finds;

That Mahalia J. Mitchell (Mahaley J. Mitchell) departed this life on the 18th day of December A. D. 1915, intestate, and a resident of Tulsa County, Oklahoma.

That on the 15th day of March 1916, Anna Freeman was appointed administratrix of said estate, and qualified as such administratrix on the 22nd day of March 1916, and letters of administration issued to her.

III

That due and proper notices were given to creditors to present their claims within four months from said appointment or be forever barred.

IV.

That the only claim presented to the administratrix or to this court for allowance and payment was the funeral bill of the deceased which was presented to the administratrix and by her paid. That no other claims have been presented nor allowed.

That at the time of her death Mahalia J. Mitchell (Mahaley J. Mitchell) was the owner of Lots one (1) and two'(2) of block seven (7) of the Fairview Addition to the City of Tuls a , Oklahoma.

That Mahalia J. M_itchell (Mahaley J. Mitchell) died as the result of a gunshot wound, inflicted upon her by her husband, Charley Mitchell; that Charley Mitchell was thereafter, to-wit: O_n the 20th day of March A. D. 1916, convicted of the crime of Murder by the District Court of Osage County, Oklahoma, for the killing of said Mahalia J. Mitchell, and sentenced to twenty-five (25) years imprisonment in the State Penitentiary, at McAlester, Oklahoma and said Charley Mitchell was delivered to the Warden of said Penitentiary on the 20th day of April, 1916.

That said Mahalia J. Mitchell (Mahaley J. Mitchell) died without issue; that she died without leaving a father, her father having died a long time prior to 1915, but the deceased left her surviving her mother, MARTHA ROSS, some sisters and a brother.

That the estate of said deceased has been properly administered and said administratrix has filed her final report herein, which is this day examined and by the court approved
