XI.

That Charley Mitchell having been convicted off the crime of murder for the killing of his wife, Mahalia J. Mitchell (Mahaley J. Mitchell and sentence to the State penitentiary at McAlester, Oklahoma, cannot inherit of, nor take any interest in the estate of said Mahalia J. Mitchell.

XII.

That having died without issue, and without leaving a father, but leaving a mother, MARTHA ROSS, and sisters and a brother, the mother, Martha Ross, is the sole heir at law of MAHALIA J. MITCHELL (MAHALEY J. MITCHELL) and takes the whole of said estate, to-wit:

Lots 1 and 2 of Block 7 of the Fairview Addition to the City of Tulsa, Oklahoma; and said Martha Ross having conveyed said described property or estate to I. H. Spears, and I. H. Spears having conveyed same to S. C. Spears the same should be assigned, and decreed to the said S. C. Spears and adjudged as the property of S. C. Spears, as an alienee of the alienee of Martha Ross, sole heir at law of Mahalia J. Mitchell (Mahaley J. Mitchell) deceased.

XIII.

That there is no personal property belonging to said estate, no debts against said estate, unpaid and nothing further to be administered upon.

THEREFORE, IT IS ORDERED ADJUDGED AND DECREED BY THE COURT THAT, MARTHA ROSS, BE, AND SHE IS HEREBY DECREED, and DECLARED TO BE, THE SOLE HEIR AT LAW OF MAHALIA J. MITCHELL, (MAHALEY J. MITCHELL) DECEASED, AND AS SUCH SOLE HEIR AT LAW ENTITLED TO THE WHOLE OF THE ESTATE OF SAID MAHALIA J. MITCHELL, DECEASED, to-wit: LOTS ONE (1) AND TWO (2) IN BLOCK SEVEN (7) OF THE FAIRVIEW ADDITION TO THE CITY OF TULSA OKLAHOMA; AND SAID MARTHA ROSS HAVING CONVEYED SAID DESCRIBED LAND TO I. H. SPEARS, and I. H. SPEARS CONVEYED SAME TO S. C. SPEARS WHO NOW HOLDS THE SAME, SAID DESCRIBED LOTS, One (1) and Two (2) of Block Seven (7) of the Fairview Addition to the City of Tulsa, are adjudged, decreed and assigned by the court to said S. C. Spears as the grantee of the grantee of said Martha Ross;

It is further ordered adjudged and decreed by the court that no other person or persons have any right, title or interest in and to said lots above described as heir at law of Mahalia J. Mitchell, deceased, except the grantee or grantees of Martha Ross, the sole heir at law of Mahalia J.
