## ORDINANCE No. 2422. COMPARED

An ordinance vacating an alley, in Block 7, BUENA VISTA PARK ADDITION TO THE CITY OF TUESA, according to plat of BUENA VISTA PART ADDITION filed in the office of the Register of Deeds in November, 1908, said alley running parallel to Riverside Drive, with certain reservations and declaring an emergency.

WHEREAS, the property owners owning abutting property of the above described alley request that this alley be vacated without restrictions and abandoned as a public street and alley.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA:

SECTION 1, That the alley in Block 7, Buena Vista Park Addition to the City of Tulsa, said alley running parallel to Riverside Drive, be and the same hereby is vacated and abandoned as a public elley or highway of said City; and,

Provided, further, that the above vacation is made subject to and conditioned upon the conditions and provisions of Paragraph II, of Section 6, of the Article II of the Charter of the City of Tulsa.

SECTION 2. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance in so far as such conflict exists, are hereby repeated.

SECTION 3. That an emergency exists for the preservation of the public welfare and safety, by reason whereof, this ordinance shall take effect from. and after its passage, approval and publication.

PASSED, and the emergency clause ruled upon separately and approved , this 22nd day of May, 1923.
