PARTIAL ASSIGNMENT OF MORTGAGE.

COMPARED

WHEREAS, on the 26th day of December, 1922, Albert W. Roth, William F. Stahl and Herbert D. Mason, did execute, acknowledge and deliver to Clyde C. Cook, a certain real estate mortgage, thereby conveying to the said Clyde C. Cook the following described real estate for the purpose of securing the payment of four promissory notes, dated December 26th, 1922, each in the amount of Two Thousand, Two Hundred (\$2,200.00) Dollars, due on or before one, two, three and four years from date respectively, all bearing interest at seven per cent payable semi-annually, and payable to the said Clyde C. Cook, to-wit:

North Twenty-five (N 25) feet of Lot Four (4), and the South twelve and one-half (S 12½) feet of Lot Five (5), in Block One Hundred Thirty-eight (138), of the Original Town, now City of Tulsa, according to the recorded official plat thereof, in Tulsa County, Oklahoma;

which said real estate mortgage was recorded in the records of the County Clerk of Tulsa County, Oklahoma, on December 30th, 1922, and bearing Instrument No. 217845, and recorded in Book ----- at page ----- of the records of said office; and

WHEREAS, on the 24th day of January, 1923, the aforesaid Clyde C. Cook did for a good and valuable consideration, sell and deliver to Exchange Trust Company, a Corporation, of Tulsa, Oklahoma, two (2) of the above described promissory notes, to-wit: the notes maturing on December 26th, 1923 - and the note maturing on December 26th, 1924, in the respective sums of \$2200.00 each, and did on said date execute and deliver to the said Exchange Trust Company a Partial Assignment of the aforesaid real estate mortgage insofar as the same secured the payment of the said two promissory notes; and
