TOGETHER with all and singular, the producing oil wells, buildings, improvements, roads, railroads, streets, ways, alleyways, passages, waters, water courses, easements, riparian and other rights, privileges, hereditaments and appurtenances whatsoever unto any and every of the premises and estates hereby granted and conveyed, belonging and appertaining, and the reversions and remainders, and all the estate, right, title, interest, possession, claim and demand of every nature and kind whatsoever of the Company as well at law as in equity of, in and to the same, including all tanks, derricks, pipe lines, pipes, pumps, pump lines, power houses, and all engines, boilers, machines, machinery, fixtures, appliances, implements and equipment now or hereafter located on said premises and in the buildings and structures constituting a part of properties aforesaid.

And the Company has also pledged, assigned, transferred and set over and by these presents doth pledge, assign, transfer and set over unto the Trustee and its successors in the trust, all right, title and interest which the Company may now have, or to which the Company may hereafter become legally or equitably entitled, in and to the following described personal property;
