TO HAVE AND TO HOLD the lands, interest in lands, leaseholds, plants and appurtenances, and other property hereby granted, pledged and conveyed, or intended to be granted, pledged and conveyed, unto the Trustee, its successors in the Trust, and its and their assigns forever.

BUT IN TRUST, NEVERTHELESS, under and subject to the conditions hereinafter set forth, for the common and equal use, benefit and security of all and singular the person or persons, firm or firms and body or bodies politic or corporate who shall, from time to time, be the holders of the First Mortgage Bonds, or the coupons appertaining to the First Mortgage Bonds executed and delivered by the Company and authenticated by the Trustee under the terms hereof, and without preference or priority of any of said bonds over any of the others by reason of priority in date or in the time of issue, sale or negotiation thereof, or otherwise howsoever, so that each and every First Mortgage Bond issued or to be issued hereunder shall have the same right, lien and privilege under and by virtue of this Indenture, and so that the principal and interest of each such bond shall, subject to the terms hereof, be equally and proportionately secured hereby as if all such bonds at any time outstanding had been duly issued, sold and negotiated simultaneously with the execution and delivery of this Indenture.

AND IT IS HEREBY COVENANTED AND DECLARED that all of said Series "A" First Mortgage Bonds in the amount of \$4,600,000 are to be executed, authenticated and delivered forthwith; and that further series in such further amounts not exceeding the aggregate of \$5,400,000 as shall be satisfactory to the Company and to a majority in amount of the holders of all bonds issued hereunder and outstanding at the time any such additional series is to be issued, with the stipulation and conditions that no such additional series of bonds shall be issued by
