PETITION FOR APPROVAL OF DEED OF
FULL-BLOOD INDIAN HEIR OR INHERITED
LAND.

Your petitioner, Chas. Page, respectfully represents and shows to the court as follows
That Samuel Adams was a full-blood citizen of the Creek Nation, and was enrolled upon the final approved roll of the Creek Nation, opposite roll number 6957, and, that as such citizen of the Creek Nation there was allotted to said Samuel Adams, the following described real estate and premises, situate in Tulsa County, State of Oklahoma, to-wit:

The South half of the Southeast quarter and the Northeast quarter of the southeast quarter of Section 2, township 19 North, Range 11 East, of the Indian base and meridian.

That said Samuel Adams died intestate in Creek County, State of Oklahoma, on or about the 13th day of February, 1911, and left surviving him as his sole and only heir-at-law his lawful wife, Anna T. Adams, a full-blood citizen of the Creek Nation, enrolled upon the final roll of said Nation, opposite roll Number 5424, and Jim Adams, an infant son of the said Samuel Adams and Anna T. Adams; that the said Jim Adams died on or about the 19th of February, 1911, and after the death of the said Samuel Adams said infant Jim Adams being at the time of his death about seven months' old.

That on the death of Samuel Adams, deceased, the said Anna T. Adams, as his surviving wife, inherited an undivided one-half interest in and to the real estate and premises hereinbefore described, and that said Jim Adams inherited the other undivided one-half interest of said real estate and premises on the death of his father, the said Samuel Adams, deceased, and that upon the death of said Jim Adams, the said Anna T. Adams inherited all the right, title and interest of her said son, Jim Adams, in and to said real estate and premises, so that after the death of said Samuel Adams, and the said Jim Adams, the said Anna T. Adams inherited and became the absolute owner in fee simple of all the real estate and premises hereinbefore described;

That on the 21st day of February, 1911, the said Anna T. Adams as sole heir-at-law of said Samuel Adams, deceased and of said Jim Adams, deceased, executed to one Ethel Davis a warranty deed conveying to the said Ethel Adams the real estate and premises hereinbefore described for a consideration of Twelve Hundred (\$1200.00) Dollars, which was duly paid to
