That whereas, on the 3rd day of June, 1918, Terrace Drive Company, a corporation, was the owner of blocks 2, 3 and 7 of Terrace Drive addition to the City of Tulsa, Tulsa County, Oklahoma, according to the recorded plat thereof; and,
